#1: IV Expo Fair Board Squatters

The Imperial Valley Fair and Fiesta is legally supposed to be run by a **Board of 9 individuals**who appoint a Fair CEO.

These 9 members of the Board make and execute policy, are involved in general operations of the fair and its grounds, including handling of several million dollars annually.

The 9 members are supposed to be appointed by the Governor of California, after filling out this form, and serve **terms of 4 years each**.

When things work normally, folks from the local

community without a "conflict of interest or an appearance of conflict of interest" *cough *cough * apply for the Fair Board. After careful review and consideration, the Governor's office selects applicants to fill vacant seats.

If there is no suitable replacement for an empty seat, a **short** grace period is extended until a **qualified applicant is found.**

Despite seats being **expired for months to over six years**, and dozens of local volunteers applying for the Board over the years, seats still remain unfilled and this occupied by a *not-so-temporary-placeholder*.

That is why it is so crucial to apply NOW. Your, yes, **YOUR** personal application, that takes only about 10 minutes, sends a message to Sacramento that there are big problems brewing with our Fair Management.

Our Fair Board needs young, fresh blood who can stand up for the best interests of our kids and community, not bend to the will of out of town Fair Managers.

Seriously, take 10 minutes to apply!

- 1. Open the link to open the online application.
- 2. On the drop down menu for position sought, select "Agricultural Assn., Dist. 45, CA Mid Winter Fair and Fiesta"

- 3. Take 10 minutes to fill out the one page form to apply.
 - 4. Whether or not you really want to be on the Board, the surge of 100+ applications submitted sends a message to Sacramento about gross misconduct in Fair management.
 - 5. Send Sacramento a message now.

#2: The Very Public Hiding of Public Information

What do the Imperial County Board of Supervisors, the Imperial Irrigation District, the Imperial County office of Education, the City of El Centro, the City of Brawley, the City of Calexico, the City of Holtville, all have in common?

They have their public meeting minutes publicly available. That means, not only are they given freely if asked for, but they are available online on their websites. Most of these public institutions even *VIDEO*their meetings and post those videos online for all to see. These institutions show from a surface level that they care about being open and transparent, even if no one is particularly interested in looking into minutes and such.

Yet, people across the Imperial Valley have made their **voice loud and clear demanding** the fair to **publicly disclose minutes**, just like any other public institution that fancies itself as *transparent*.

There is one small victory here! After the large public outcry against the fair's unwillingness to publicly disclose minutes through four simple words, "OPEN THE BOOKS", and a Valley wide Op-Ed, *some* minutes have been released.
